1. The Pig Scramble will be held in the livestock arena on Wednesday at 8:00 p.m.
2. Contestants must have reached their 8th birthday and not have passed their 13th birthday by September 1st of the year they participate in this contest and must be a Mason County resident. Winners in previous Pig Scrambles will not be eligible to participate again. An exception would be made only if there are not enough first-time participants.
3. Each participant must secure an application and have it signed by a parent or guardian and 4-H Leader prior to participating. Applications, along with complete Rules and Regulations, will be available in the fair office on the fairgrounds during the fair (starting Monday and at noon on Wednesday). If more than twelve (12) applications are received, a lottery drawing will be held. The Queen will draw names on Wednesday at 12:30 p.m. Names of participants and alternates will be posted outside the fair office.
4. **Contestants must comply with the Rules and Regulations as listed with the application.** Rules and Regulations will be available at the Mason County Extension office prior to the fair.
5. Participants who catch pigs are expected to join 4-H in September and carry Swine as a project for at least one (1) year.
6. Winners will not be given the pig they catch, but will be given a pig furnished by the Pig Scramble Committee between April 1-15 of the following year. That pig will be required to be shown in a special "Pig Scramble Class" in that year's Mason County Fair.
7. Neither the Mason County 4-H & Junior Show Association nor its affiliates will be responsible for any accidents connected with the contest.
